In addition to each of the fees listed above, the following items are also required for service:

- \* New Owner must be free of any outstanding Bold Springs Water Supply balances.
- \* Completed Bold Springs WSC Service Application & Agreement and notarized Easement, if no easement on file.
- \* Proof of current ownership, such as a copy of warranty deed showing sale of property between parties.

If the above criteria are not met, BSWSC has the right to discontinue service to the property, disconnect and remove the meter.

**Late Charge Fee:** \$ 25.00

Applied to accounts not paid on or before the 15<sup>th</sup> day of the month.

**Service Trip / Disconnect Fee:** \$ 30.00

Applied to accounts when a service trip is made for disconnection and/or other purposes.

**Reconnect Fee:** \$ 30.00

Applied to accounts for reconnecting service after being disconnected for any reason. NOTE: Disconnect fees may also apply.

**Return Check Fee:** \$ 35.00

**Notification Fee:** \$ 25.00

Applied to member accounts for any notification that must be sent for any reason to notify of payment or service problem.

**Billing Procedures:**

The meters are read on or around the 20<sup>th</sup> day of each month. The bills are mailed on the First day of the month. The bills are due upon receipt and are considered past due if received after the 15<sup>th</sup>. Payment must be in the Office by this date or postmarked by the US Postal Service by this date. Payments received or postmarked after the 15<sup>th</sup> day of the month will be assessed a \$25.00 late charge.

If payment is not received by the 18<sup>th</sup> day of the month a Disconnect Notice will be sent. IF PAYMENT IS NOT RECEIVED BY THE DUE DATE ON THE NOTICE, SERVICE WILL BE DISCONNECTED. US POSTAL POSTMARK DOES NOT APPLY TO RECEIPT OF PAYMENT FOR DISCONNECTS. If service is disconnected, a \$30 Service Trip Fee will be assessed. TO RECONNECT WATER SERVICE the account balance must be paid in full, including Service Trip Fee and Reconnect Fee of \$30.
